NOTICE OF ORAL ARGUMENT

Dear Counsel:

Your case has been set for oral argument in the Supreme Court of New Mexico as reflected on the attached oral argument calendar. Unless otherwise noted on the attached calendar or ordered by the Court, the time allotted to each side for oral argument will be in accordance with Rule 12-319(E) NMRA. In the event of inclement weather, please check the local news outlets for notice of any delays or closures for the Supreme Court Building. If the building is closed, your argument will be rescheduled to another day. If the Court is on a two-hour delay, morning arguments will begin ninety minutes later and afternoon arguments will remain on the original schedule.

Please confirm your receipt of this notice of oral argument at least one week before the date of your oral argument by sending an email to nmsupremecourtclerk@nmcourts.gov or by calling the telephone number listed above. When contacting this office, please also provide the names of the attorneys who will be attending argument. In this regard, please note that there is room at counsel's table to seat up to six attorneys per side. Any additional attorneys in attendance will need to be seated behind the bar. Please also note that the parties to the case and any other non-attorneys may not be seated at counsel's table and must be seated behind the bar. Seating in the courtroom is limited and may not be reserved in advance.

If you plan to use any exhibits or other demonstrative aids during argument, you must notify the Clerk's Office in advance and indicate whether opposing counsel concurs in your use of such material. If opposing counsel does not concur, you must file a motion seeking permission to use your proposed material at least two business days before the date of your oral argument. If you plan to distribute any material to the Justices during oral argument, please provide the necessary copies directly to the Court clerk during your argument at the appropriate time, with a copy to opposing counsel, and the clerk will then distribute the material to each Justice seated at the bench.

Because parking around the Supreme Court Building is very limited, please plan to arrive early to find parking. On the day of your argument, you must check in at the Clerk's Office at least fifteen minutes before the start of your argument. At that time, you will be asked to identify the attorney or attorneys who will present oral argument for your side, specify the order in which they will present their argument, and specify the amount of time to be allocated to each attorney, including the amount of time to be reserved for rebuttal if applicable to your side.
