Among the key topics discussed during this conversation were utilizing valuable industry insights to share best practices for trade compliance and effectiveness of rules as well as maximizing industry-government engagement to integrate industry and stakeholders into the regulatory process.

Middle East Discussions

Upon request of DAEC Executive Membership, DAEC sought insight from the Administration pertaining to the current and forecasted climate in the Middle East as it relates to Congress and the future of U.S. Defense exports. The team sat down with prominent policy makers at the U.S. Department of State (Acting Assistant Secretary for Near Eastern Affairs, Ambassador Satterfield and Deputy Assistant Secretary for Arabian Gulf Affairs in the Near East, Timothy Lenderking), for closed door, on the record discussions and had conversations with other relevant offices within the

interagency. The purpose of these meetings was to bridge gaps of information left by various reports and media outlets on the Congressional view with respect to this Administration and sales of military capability to the Middle East.

Aspen Security Forum July 17

Webster is attending the eighth annual Aspen Security Forum. The Forum welcomes top-level current and former U.S. officials from relevant security agencies, as well as industry leaders, leading journalists and academics. On-the-record information will be shared in a read-out with members upon Keith's return.
