Thanks to all of the individuals just mentioned above, here are some highlights of our goals and the accomplishments towards them that we made this past year:

Growing Membership and Increasing Membership Value:

- The Chamber membership continued to grow to approximately 1,200 members.

- 2,375 people's networking opportunities took flight at the Business After Hours including the Chippewa Valley Air Show Chalet and Airport Open House events.
- A record attendance of 3,470 people enjoyed the hospitality served up by 300 volunteers at the 12th Annual Breakfast in the Valley.
- 250 hit the greens in the 23rd Annual Business Salutes Eau Claire Golf Classic.
