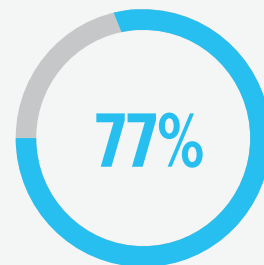

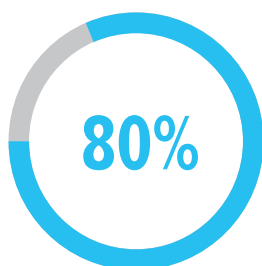
LEGISLATIVE LEADERSHIP

LEGISLATIVE VOTE SCORE

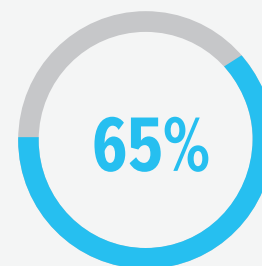


Representative Smith voted with the Chamber on **8 out of 10 votes** on our scorecard in 2019.
